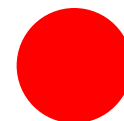

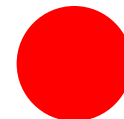

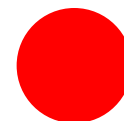




WHAT IS THE FIRSTNET NETWORK?



- A single, nationwide, reliable, highly secure and interoperable LTE broadband network dedicated to public safety.



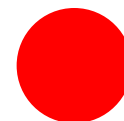


9/11 COMMUNICATIONS CHALLENGES

“As a first responder on 9/11, I experienced the communications challenges that can happen in large emergencies as networks become congested and overwhelmed”

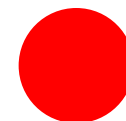
- Due to communications challenges during the response to the 9/11 terrorist attacks, the 9/11 Commission recommended the establishment of a single, interoperable network for public safety.
- **The FirstNet network is the result of the 9/11 Commission recommendation.**





FIGHTING FOR THE FIRSTNET NETWORK

- Various public safety stakeholders come together to advocate for the development of a nationwide wireless network for public safety.
- As a result of these advocacy efforts, Congress passed legislation in 2012 establishing the First Responder Network Authority (i.e. FirstNet) as an independent authority within the U.S. Department of Commerce.
- FirstNet is tasked with building, deploying and operating the 1st nationwide wireless network dedicated to public safety.





FIRSTNET SELECTS AT&T AS ITS PARTNER

- In March 2017, after a rigorous, competitive public procurement process, AT&T was chosen by the First Responder Network Authority as the nationwide public safety broadband network partner.

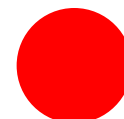

FirstNet Investments Expected to Create 10,000 Jobs

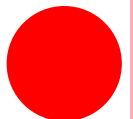
AT&T* has been selected by the First Responder Network Authority (FirstNet) to build and manage the first **broadband network** dedicated to America's police, firefighters and emergency medical services (EMS). The FirstNet network will cover all 50 states, 5 U.S. territories and the District of Columbia, including rural communities and tribal lands in those states and territories.





THE FIRSTNET FEDERAL CONTRACT

- AT&T is selected for the 25-year FirstNet federal contract.
 - AT&T will invest approx. \$40 billion to build, deploy, operate and maintain the network.
 - FirstNet will provide 20 MHz of 700MHz Band 14 (“high-value”) spectrum and \$6.5 billion to support the network buildout.
 - The FirstNet network will cover all 50 states, 5 U.S. territories and the District of Columbia.

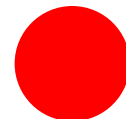

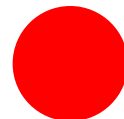


FIRSTNET SUBSCRIPTION PHASE

- Today, first responders have the opportunity to subscribe to FirstNet and receive all of the network’s benefits.
- If you use your own personal device for your volunteer firefighter service, you can subscribe to FirstNet individually.





THE BENEFITS OF FIRSTNET

- A network built exclusively for and with the input of public safety professionals.
- An exclusive, separate public safety core with end-to-end encryption.
- Priority and Preemption. No throttling on the network. Prioritization with no speed limits on voice, text or data.





THE BENEFITS OF FIRSTNET

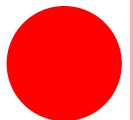
- Nationwide Interoperability.
- Exclusive FirstNet Application Ecosystem.
- 24/7/365 FirstNet Dedicated Customer Care Center.
- AT&T held accountable by a federal contract. First responders' needs won't be subjected to corporate policy shifts.





FIRSTNET DOES NOT REPLACE LMR

- **First Responders should not replace their Land Mobile Radios (LMR) with FirstNet.** FirstNet should be used to augment LMR by extending coverage, offloading traffic and/or providing extra interoperability.

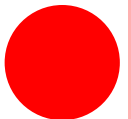
